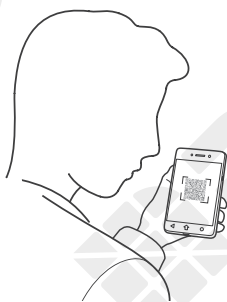

Additionally, the ONE Core features an RV levelling system for optimal stability and can function as a smart home hub, seamlessly connecting with other smart home appliances.

### 3. Preparation

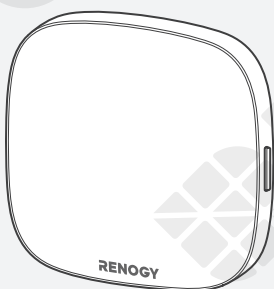
#### 3.1. Installation Site and Environment

To ensure proper running of the RV levelling function on Renogy ONE Core, ensure it is installed in a spot with the screen pointing to the front, rear, left, or right side of the RV, vertically to the RV floor. It is recommended that RV levelling blocks should be used during the levelling process.



- ⚠ Install the Renogy ONE Core indoors and prevent its components from being exposed to direct sunlight.
- ⚠ Do not expose Renogy ONE Core to flammable or harsh chemicals or vapors.
- ⚠ Keep Renogy ONE Core out of the reach of children.
- ⚠ Make sure that the Renogy ONE Core is installed with ambient temperature range from -4°F to 158°F or -20°C to 70°C.
- ⚠ Make sure that the Renogy ONE Core is installed in an environment with relative humidity between 0% and 95% and no condensation.
- ℹ To ensure quality wireless communication for Renogy ONE, keep it away from metal objects at a minimum distance of 200 mm or 7.9 inches.

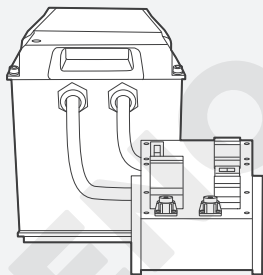
#### 3.2. Checking Renogy ONE Core



Inspect the Renogy ONE Core for any visible damage including cracks, dents, deformation, and other visible abnormalities. All connector contacts shall be clean, dry, and free of dirt and corrosion.

- ⚠ Do not use Renogy ONE Core if it appears to be damaged.
- ⚠ There are no serviceable parts in Renogy ONE Core. Do not open, dismantle, repair, tamper with, or modify it.
- ⚠ Wear proper protective equipment and use insulated tools during installation.
- ℹ Do not dispose of Renogy ONE Core as household waste. Comply with local, state, and federal laws and regulations and use recycling channels as required.

### 3.3. Checking DC Power



8V to 35V

Ensure that the connected DC power supply rates at 8V to 35V. Connecting the Core to a power source beyond the range results in a power-on failure or permanent damage to the Core.



Confirm the polarities of the devices before connecting Renogy ONE Core to a power supply. A reverse polarity contact can result in damage to the Core, thus voiding the warranty.

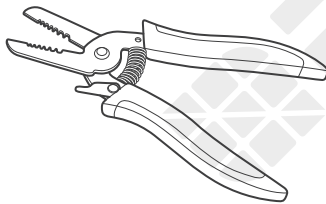

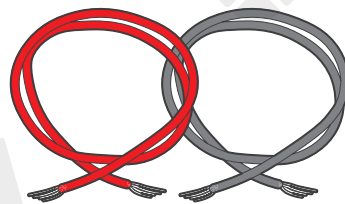
### 3.4. Extend the Power Cable

If the included power cable is not long enough for connecting Renogy ONE Core to your DC power supply, re-select a mounting position or use an extension cable ( $\geq 22$  AWG).

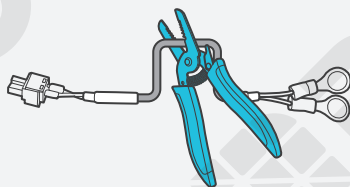

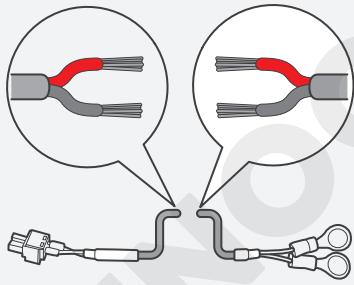
Confirm the polarities of the included cable and the extension one before connecting them. A reverse polarity contact will result in abnormal operations. The extension cable should not exceed 10 meters (32.8 feet).

1. Cut the included power cable.

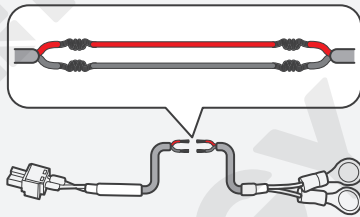




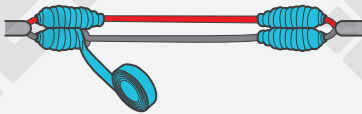
2. Strip off some of the insulation.



3. Strip some insulation off the extension cable, and connect the cable to the included power supply cable.



4. Tape over the cutoff areas.



### 3.5. How to Connect RS-485 Communication Devices (Optional)

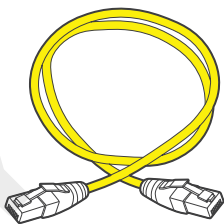
Renogy ONE Core can communicate with Renogy energy devices in several ways:

1. Bluetooth wireless communication;
2. Wired communication based on RS-485 protocol;

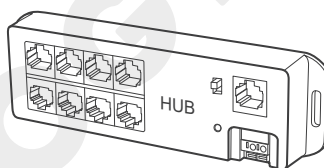
You can choose an appropriate communication method according to the actual situation.

- For Bluetooth wireless communication, communication wiring is not required.
- For RS-485 communication, you need to wire Renogy ONE Core with energy devices.

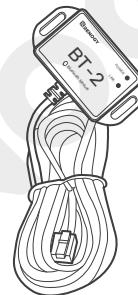

### 3.6. How to Connect to CAN Communication Devices (Optional)

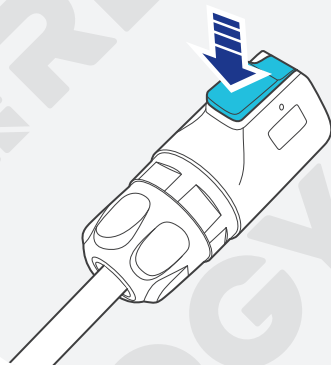
This section applies to RSHGWSN-W02W-G2 and later users only.

The second-generation and later Renogy ONE Core (RSHGWSN-W02W-G2 and later) can communicate with other Renogy devices supporting CAN communication, enabling safe operation, smart control, remote monitoring, and programmable settings.

How to wire RV-C communication cables varies depending on the connection network topology. Both backbone and daisy chain topologies are supported.

To properly connect or disconnect the LP16 Terminal Plug to or from the Renogy devices supporting CAN communication, you should

1. Ensure that the plug is oriented vertically toward the CAN1 Communication Port.
2. Press and hold the snap until the process is complete.

Shaking while plugging or unplugging is not allowed.

#### ■ Backbone Network

Ensure 120Ω terminating resistors are installed at both ends of the RV-C bus for successful communication with Renogy devices supporting CAN communication. If the RV user manual does not determine if the RV-C bus has a built-in 120Ω termination resistor, call the RV manufacturer to confirm.



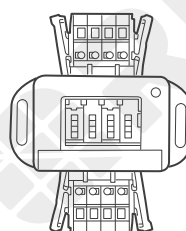
If the RV-C bus does not have a built-in 120Ω termination resistor, the Renogy ONE Core will not communicate properly with other Renogy devices supporting CAN communication. Please use the Daisy Chain Network for communication connections.

Connect devices to Renogy ONE Core according to the wiring diagram provided by the RV manufacturer. Choose proper communication cables according to your specific demands.

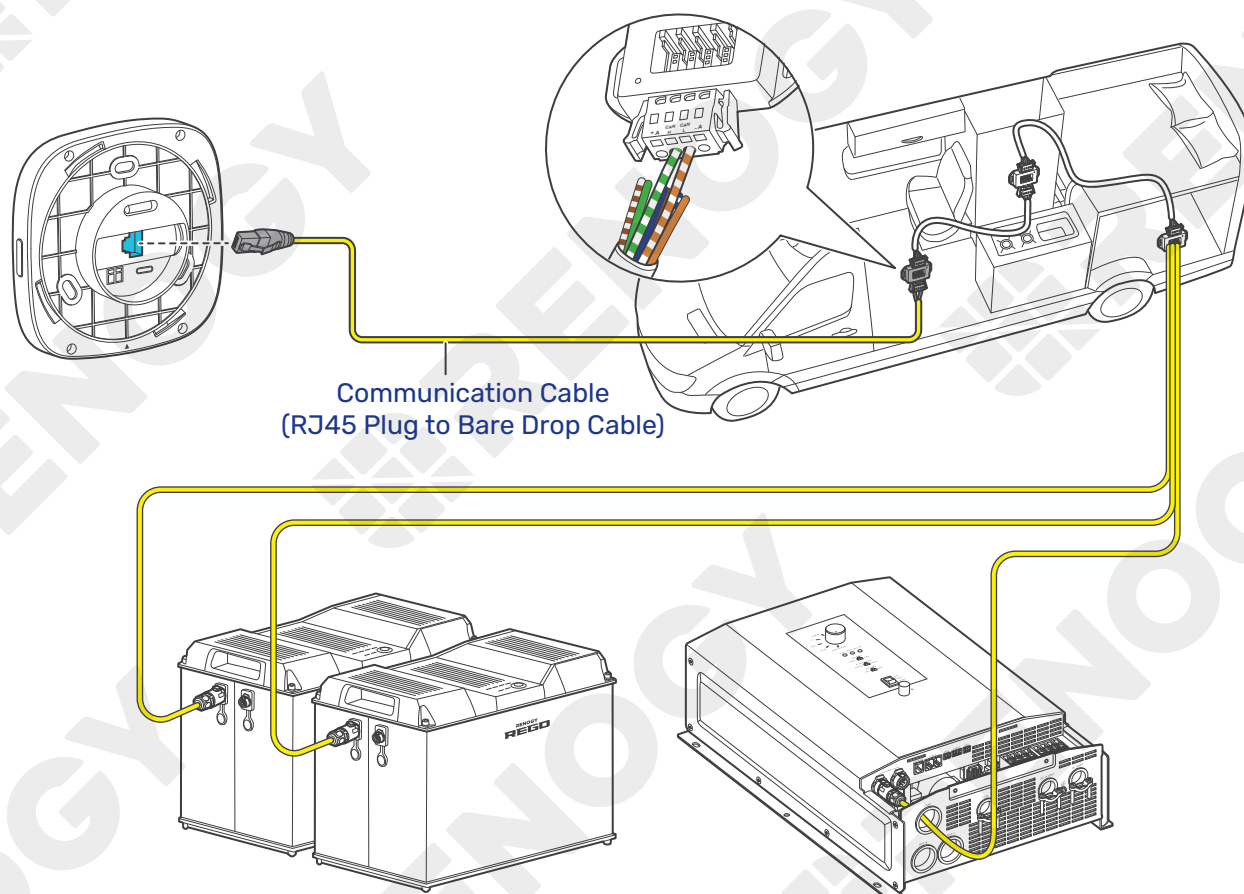
The drop cable shall not exceed 19.6 feet (6 m), and the RV-C bus shall not exceed 98.4 feet (30 m).



Different drop taps are used on the RV-C bus by different RV manufacturers. This user manual takes the pinout of the MCS MIDI Classic terminal block plug (4-Pin) as an example.

- Step 1:** Locate the drop tap (not included) on the RV-C bus that is the closest to the Renogy ONE Core installation location. The drop taps are usually located above the entry door, in the bathroom, or under the bed in the RV.
- Step 2:** Replace the terminated drop tap at either end of the RV-C bus with the Common Drop Tap (not included). Secure the bare wires of the Drop Cable (not included) onto the terminal block plug of the Common Drop Tap following the terminal block plug pinout.
- Step 3:** Connect the preembedded RJ45 connector to the RJ45 communication port of Renogy ONE Core.

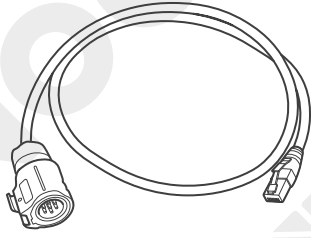
-  If the drop taps cannot be located, please contact the RV manufacturer for help.
-  Different terminal block plugs are used on different Common Drop Taps and follow different pinouts. If you are unsure about the pinout of the terminal block plug, contact the RV manufacturer.



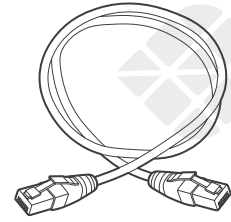
## Daisy Chain Network

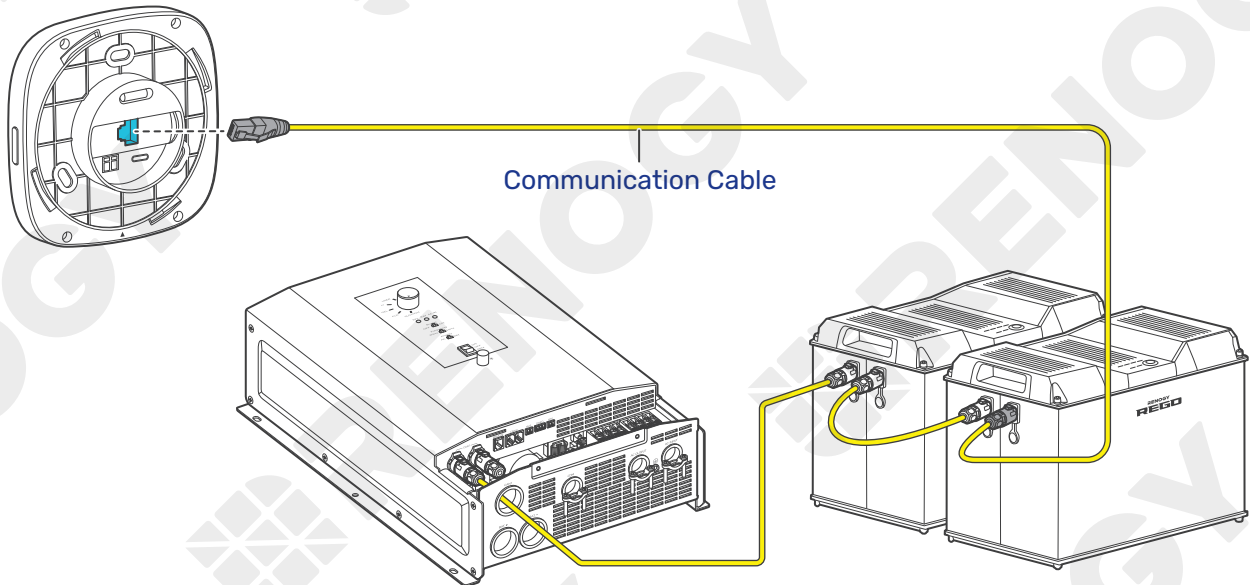

- i** Please select the appropriate communication cable based on the device communication port type. This manual uses the LP16 Plug (7-Pin) to RJ45 Communication Adapter Cable as an example.

**Step 1:** Connect Renogy devices supporting CAN communication in series through either of the CAN Communication Ports with the LP16 Plug (7-Pin) Communication Cable(s) (sold separately).

**Step 2:** Plug the Terminator Plugs (sold separately) into the free CAN Communication Ports on the first and last Renogy devices supporting CAN communication.

**Step 3:** Unplug the LP16 Terminator Plug (7-Pin) from the first or last Renogy device supporting CAN communication in the communication network. Insert the LP16 Plug (7-Pin) to RJ45 Communication Adapter Cables into the communication ports of other Renogy devices supporting CAN communication.

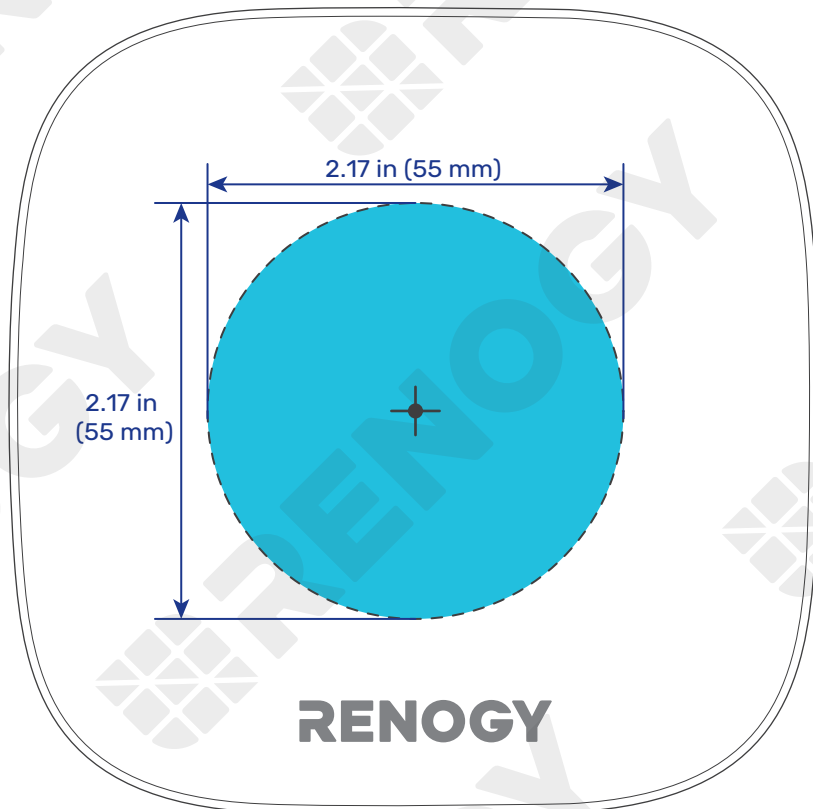

## 5. Configure Renogy ONE Core

### 5.1. Power On/Off

Long press the On/Off Button for 5s to power the Core on or off.



### 5.2. Pairing with the Renogy App

For initial startup, follow the startup wizard on the Core to pair it with the Renogy app. Alternatively, go to **System > Pair with App**.



### 5.3. Add Devices


Renogy ONE Core can wirelessly connect to Renogy Bluetooth, Bluetooth mesh, and Zigbee devices concurrently.

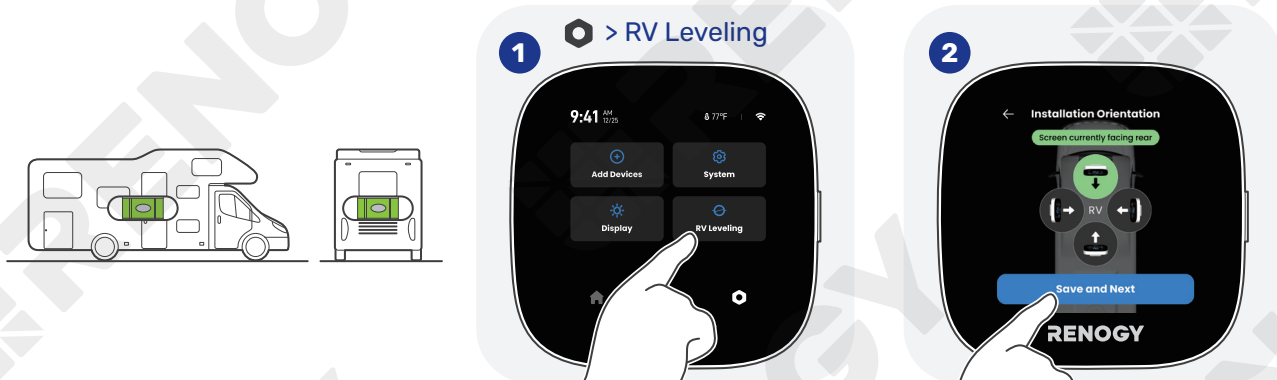
**Info** Before adding the device to Renogy ONE Core, please make sure that the firmware version of Renogy ONE Core has been updated to the latest version.






## 5.4. RV Levelling

To enable the RV levelling function (only available for regions outside the U.S.) on Renogy ONE Core, ensure it is installed in a spot with the screen pointing to the front, rear, left, or right side of the RV, vertically to the RV floor. It is recommended that RV levelling blocks should be used during the levelling process. Go to  > RV Levelling, and follow the tips in the levelling wizard.



 RV levelling calibration on Renogy ONE Core is required each time the installation site for the Core is changed.

## 6. Troubleshooting

Issue	Possible Cause	Solution
<b>Power on failure</b>	Reverse polarity contact	Check whether the positive and negative polarities of the power terminals are normally connected.
	Renogy ONE Core damaged	Contact our customer service through <a href="https://renogy.com/contact-us/">renogy.com/contact-us/</a> .
<b>Failure to add devices or smart accessories</b>	The device is too far away from Renogy ONE Core.	Move the device closer to Renogy ONE Core. <ul style="list-style-type: none"> <li>● Bluetooth: within 10 m in an open environment.</li> <li>● Zigbee: within 50 m in an open environment.</li> </ul>
	The smart accessories have been connected to other devices.	Reset the smart accessories, and redo adding. For details, see the user manuals of specific accessories at <a href="https://renogy.com/support/downloads">renogy.com/support/downloads</a> .
	The device or smart accessory is incompatible with Renogy ONE Core.	Use Renogy devices and smart accessories.
<b>Wi-Fi connection failure</b>	Unsupported Wi-Fi frequency band	Ensure the Wi-Fi router is working on the 2.4 GHz or 5 GHz band.
	WPA3 encryption	Disable WPA3 encryption on the Wi-Fi router.
	Wrong password	Enter the correct Wi-Fi SSID and password.
	Signal shielding	Ensure that there is no metal object around Renogy ONE Core and the Wi-Fi router because it may undermine the wireless communication.
<b>BT-1 or BT-2 communication failure</b>	Unstable communication quality	Unplug the BT-1 or BT-2 Bluetooth module from the devices, and then plug it to the devices again. Redo device scanning on Renogy ONE Core if necessary.
<b>Laggy and unresponsive operations on the LCD</b>	Improper power supply	Check the voltage of the power supply. Make sure the voltage is 8V to 35V DC for the Power Port or 5V DC for the Type-C port, and the voltage should be stable.
<b>Failure to find Bluetooth devices</b>	<ol style="list-style-type: none"> <li>1. The Bluetooth device is powered off.</li> <li>2. The Bluetooth device has been paired with Renogy app.</li> <li>3. Bluetooth on the device is turned off.</li> </ol>	<ol style="list-style-type: none"> <li>1. Power on the Bluetooth device.</li> <li>2. Unpair the device from the app first and then redo on Renogy ONE Core.</li> <li>3. Turn on Bluetooth on the device.</li> </ol>

Issue	Possible Cause	Solution
<b>Inaccurate or delayed RV level data on both the Core and the Renogy App</b>	The RV is not parked on a level surface during initial installation of Renogy ONE Core.	Park the RV on a level surface, and redo RV levelling on Renogy ONE Core.
	The bubble is not centered in the bubble level when you install the base.	Park the vehicle on a level surface, rotate and remove the Core from its base. Readjust the base to ensure the bubble is centered before redoing RV levelling on the Core.
	The performance of the built-in 6-axis sensor is affected by environmental factors such as temperature.	Install the Renogy ONE Core in a well-ventilated location to prevent RV levelling data discrepancies due to extreme temperatures.
<b>Inaccurate or delayed RV levelling data on the Renogy App</b>	Renogy ONE Core is placed too far away from your phone or there are obstacles around Renogy ONE Core to affect normal Bluetooth communication between the Core and your Renogy app.	<ul style="list-style-type: none"> <li>● Ensure there is no metal object around Renogy ONE Core.</li> <li>● Reinstall Renogy ONE Core at a site which is within a range of 10 meters of the driver's cabin.</li> </ul>

### How to connect Renogy ONE Core with different types of batteries to set up a battery monitoring system?

The Renogy ONE Core can function as a power monitor when it is connected to Renogy batteries that support Bluetooth (built-in or with external BT-1/BT-2 modules) and RS-485.

### Does Renogy ONE Core support RV-C communication?

Renogy ONE Core comes in two models: RSHGWSN-W02W-G1 (no CAN communication) and RSHGWSN-W02W-G2 (supports CAN communication).

### How can I check the RV levelling status?

You can check it locally on Renogy ONE Core or remotely on the Renogy app when the app is paired with the Core via Bluetooth.

### What is the operational altitude range for the Renogy ONE Core?

It can work normally at altitudes below 5000 meters.

### ■ Does Renogy ONE Core come with a shunt?

No, it does not come with a shunt. Visit [renogy.com](https://renogy.com) for further updates.

### ■ Does Renogy ONE Core support 5 GHz Wi-Fi network?

Yes. It supports 2.4 GHz and 5 GHz Wi-Fi bands.

### ■ Does Renogy ONE Core support WPA3 encrypted Wi-Fi networks?

No. It does not support WPA3.

### ■ Is Renogy ONE Core compatible with third-party Zigbee 3.0 devices?

We cannot guarantee the compatibility between Renogy ONE Core and third-party Zigbee 3.0 smart home devices. Therefore, it is recommended to use smart accessories that have been authorized by Renogy with your Renogy ONE Core, such as Smart Plug, Motion Sensor, Door & Window Sensor, and Smart Relay.

### ■ Do the configured smart scenes in Renogy ONE Core still work when it is offline?

Yes, the configured smart scenes in Renogy ONE Core will still work when it is offline. Renogy ONE Core utilizes the Zigbee 3.0 protocol to establish wireless connections with smart accessories. When you set up a smart scene for home automation, the configuration is saved within the system of Renogy ONE Core. This means that even if the Wi-Fi network is unavailable, Renogy ONE Core can still communicate with and control smart accessories through Zigbee 3.0.

### ■ What kind of power systems can Renogy ONE Core work with?

Renogy ONE Core can be supplied by a 5V DC source via Type-C or an 8V to 35V DC source via the power cable.

As for energy monitoring, Renogy ONE Core allows you to monitor power devices rated at 12V DC or 24V DC.

### ■ How long will Renogy ONE Core store the data locally?

Renogy ONE Core can store data locally for 30 days

### ■ How to install Renogy ONE Core on a table?

It is recommended to install Renogy ONE Core on a table when it is supplied by a Type-C cable. You can just put it in the package box.

### ■ What are the levelling requirements for the initial installation of Renogy ONE Core in an RV?

During the initial installation, it is important to park your RV on a level surface. Ensure that the Renogy ONE Core's bubble level is positioned in the center during the installation process. This will help to achieve proper levelling and ensure optimal performance.

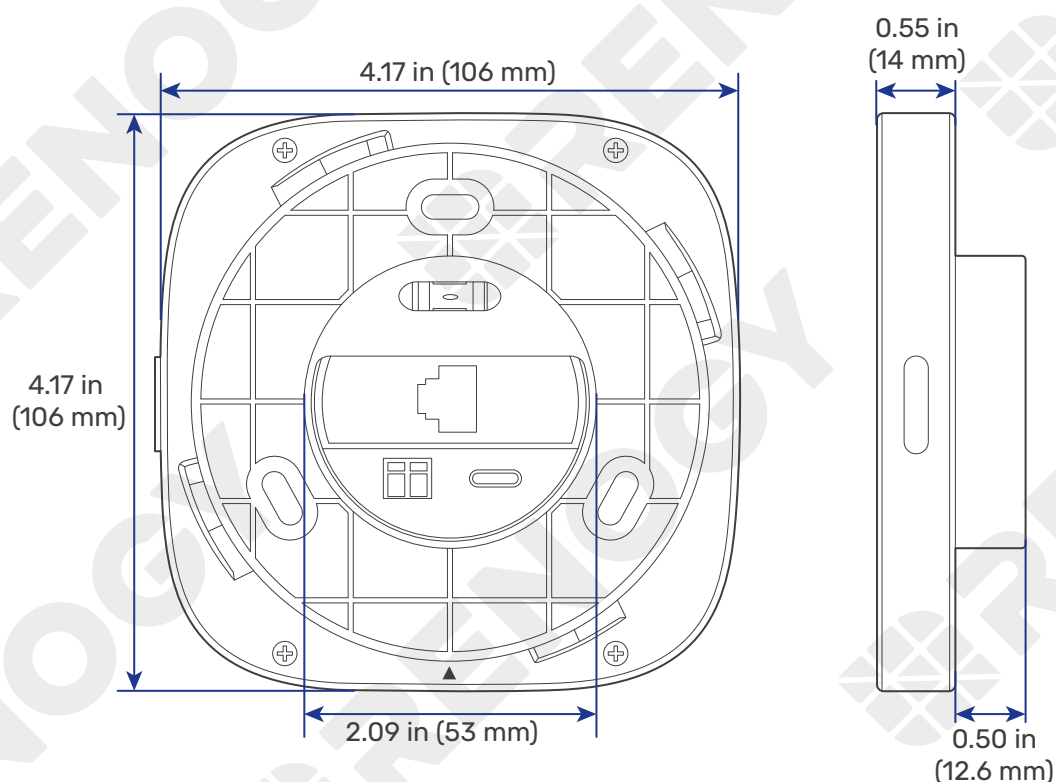
### ■ Is it normal for the RV levelling data in Renogy ONE Core to have minor fluctuations when the vehicle's engine is running but the vehicle is not moving?


Yes. This is because the built-in 6-axis sensor in the Core is capable of detecting vibrations caused by the vehicle's engine. Therefore, slight variations in the RV levelling data can occur under such conditions. As long as the fluctuations are small and do not affect the overall accuracy of the levelling calibration, it is considered normal operation.

## Maintenance

### Inspection

For optimum performance, it is recommended to perform these tasks regularly.

- Check the appearance of the Renogy ONE Core to make sure it is clean and dry.
- Ensure the Renogy ONE Core is installed in a clean, dry and ventilated area.
- Ensure there is no damage or wear on the cables.
- Ensure the firmness of the connectors and check if there are any loose, damaged or burnt connections.
- Ensure that the Battery indicator and Fault indicator are in normal state.
- Ensure there is no any corrosion, insulation damage, or discoloration marks of overheating or burning.



Risk of electric shock! Make sure that all power is turned off before touching the terminals on the Renogy ONE Core.



In some applications, corrosion may exist around the contacts inside the connector. Corrosion can loosen springs and increase resistance, leading to premature connection failure. Please apply dielectric grease to each connector contact periodically. Dielectric grease repels moisture and protects the connector contacts from corrosion.

### Cleaning

Follow the steps below to clean the Renogy ONE Core regularly.

- Shut down Renogy ONE Core. If you clean the inside of the device, you need to disconnect the power supply.
- Wipe the charger housing and connector contacts with a damp cloth or non-metallic brush. If it is not clean after wiping, use a household cleaner.
- Dry the Renogy ONE Core with a clean cloth and keep the area around the Renogy ONE Core clean and dry.
- Make sure the Renogy ONE Core is completely dry before reconnecting the connector to the Renogy ONE Core.

### Storage

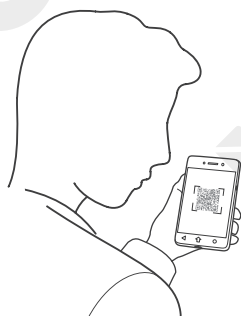
